KNOW ALL MEN BY THESE PRESENTS, that OAKRIDGE "V" GONDOMINIUM ASSOCIATION, INC., a corporation not-for-profit under the laws of the State of Florida, pursuant to the provisions of the Articles of Incorporation of OAKRIDGE "V" GONDOMINIUM, being that certain condominium recorded in the Official Record Book 7153 at Page 138 of the Public Records of Provent County Florida has and does bearing and Public Records of Broward County, Florida, has and does hereby amend said Articles of Incorporation as follows:

The first paragraph of Article VIII, appearing on page 3 of the Articles of Incorporation is amended to read:

"The affairs of the Association will be managed by a Board of Directors consisting of five Directors who need not be members of the Association and who shall be elected for a term of two years."

The first sentence of Article IX appearing on page 3 of the, Articles of Incorporation is amended to read as follows:

"The officers of the Association shall be elected by the Board of Directors at the first Annual Meeting and biennially thereafter, commencing with the year 1980, by the members of the Association for a term of two years and shall serve at the pleasure of the Board of Directors."

These amendments shall take effect as of February 1.0th, 1930.

AMENDMENTS TO THE SY-LAIS

KNOW ALL MEN BY THESE PRESENTS, that OAKRIDGE "V" CONDO-MINIUM ASSOCIATION, INC., a corporation not-for-profit under the Laws of the State of Florida, pursuant to the BY-LA/S of OAKRIDGE "V" CONDOMINIUM, being that certain condominium recorded in Official Record Book 7153 at page 133, of the Public Records of Broward County, Florida, has and does hereby amend said BY-LA/S as follows:

Article 3.1 "ANNUAL MEETING." appearing on page 2 of the BY-LANS is amended to read as follows:

"3.1 ANNUAL MEETING. The annual members meeting shall be held at least once each calendar year at the office of the ASSOCIATION, Deerfield Beach, Florida, or such other place designated on the notice thereof, for the purpose of transacting the business authorized to be transacted by members."

Article 4.1 "MANAGEMENT OF ASSOCIATION," appearing on page 3 of the BY-LA/S is amended to read as follows:

"4.1 MANAGEMENT OF ASSOCIATION. The affairs of the ASSOCIATION shall be managed by a BOARD OF DIRECTORS (hereinafter referred to as BOARD) consisting of five persons."

The first sentence of Article 5.1 "GENERALLY", appearing on page 7 of the BY-LAMS is amended to read as follows:

"5.1 GENERALLY. The officers of the ASSOCIATION shall be a President, one or more Vice-Presidents, a Treasurer, a Secretary and, if desired, one or more Assistant Secretaries, all of whom shall be elected biennially by the members commencing with the year 1930, for a term of two years and who may be peremptorily removed by a majority vote of the Directors at any meeting."

These amendments shall take effect as of February 10th, 1930.
